


## What is **ESSA** and How Can I be Involved?

## ESSA is . . .

The Every Student Succeeds Act (ESSA) is the federal K-12 education law of the United States. ESSA was signed into law in 2015 and replaced the previous education law called "No Child Left Behind." ESSA extended more flexibility to States in education and laid out expectations of transparency for parents and for communities.

# What ESSA Funding Does the School Receive?

- <u>Title I</u> provides funding to local school districts to improve the academic achievement of disadvantaged students (ELA, Mathematics, Science, & ESL)
- <u>Title IIA</u> provides funding to local educational districts to **improve the quality and effectiveness of teachers, principals, and other school leaders**
- <u>Title IV</u> provides funding local educational district's to provide students with a well-rounded education, improve school conditions for student learning

## Definition of Title I:

- Title I provides federal funding to schools to help students who are low achieving or at most risk of falling behind.
- Title I is allocated to schools based on the percentage of student receiving free/reduced lunch.
- Schools with a percentage of at least 40% are eligible for a schoolwide program.

## Orange Elementary Schools operates a **Title I Schoolwide Program**.



## **Schoolwide Means:**

- The school uses Title I funds to upgrade the entire educational program of the school.
- Title I funds are used to serve all children in order to raise academic achievement.
- Title I funds will be used to provide additional assistance to all students who experience difficulties in meeting the State's performance targets.

### To be a "Schoolwide" School:

- The school must have a free/reduced lunch count of at least 40%.
- The school must collect and analyze data that affects student achievement.
- The school must develop a comprehensive site plan and annually review the effectiveness of the plan.

### Summary:

Teachers will use ongoing formative assessment data and routine progress monitoring data to adjust instruction in order for students to make measurable gains. The data utilized will include DIBELS 8, STAR early literacy, STAR reading, STAR Math, and ZEARN math data.

Teachers will utilize evidence-based practices, core, high quality, curriculum materials, and culturally responsive practices to provide ALL students with access to grade-level standards ensuring equal access to the curriculum; and ALL students will have access to tiered academic and behavioral supports in order to make meaningful gains.

### **Focus Goals**

As a result of focusing on this priority, by June of 2024 the district anticipates seeing an increase in student proficiency in:

- 60% of students leaving Grades K-2 at benchmark levels as measured by DIBELS, Star Early Literacy, STAR Reading, and STAR Math;
- 15% increase in reading and math proficiency for students in Grades 3 - 6 as measured by DIBELS, Star Early Literacy, STAR Reading, and STAR Math;
- close the gap between the district and State in MCAS meeting expectations from over 20% (current) to within 10% of the state by EOY 2024 for Grade 3; and
- decrease the gap by 5% for Grades 4-6

### **Curriculum and Instructional Strategies:**

- To provide students with supplemental reading support with a Title I Teacher at both Fisher Hill and Dexter Park
- To provide students with supplemental mathematics support with a Title I Teacher at both Fisher Hill and Dexter Park
- To provide teachers with supplemental instructional materials to provide in-time supports for students
- To provide students with supplemental programming (Summer Learning Programs & Vacation Programs)

- We assess all students in Grades K-6 using the mClass DIBELS 8 assessment: BOY, MOY, & EOY
- We will monitor students' attendance with the use of a new data dashboard to ensure that all students receive adequate instructional time

## Title I Parent Notification Requirements

### **Parent Involvement Policy**

- The Orange Elementary Schools holds an annual ESSA/Title I presentation and families are provided with an overview of the ESSA services offered at the school
- In the spring, a Title I/Curriculum Night is offered to students and family. Students and their families come to the school to learn about the progress the Title I program has made in closing the achievement gap; all supplemental curricula is shared with parents/guardians at this time and expected benchmark attainment levels and the goals of the Title I program.
- Parents are informed of opportunities they have to become involved in the school and for their input and feedback. In addition, parents and students participate to learning activities and games that parents and children can participate in outside of school hours to enhance learning. After the event participants are sent a follow-up survey about the event. Results are shared with administration and Title I teachers. Information from this survey is used to adapt and change the services provided, support offered to parents, and outreach opportunities to families.
- Parents are also informed that they have the right to request a meeting at any time with their child's Title I teacher or the Title I director to discuss their child's progress or the Title I services being provided at the district/school.

  - O Students in Grades 5, 8, and HS (based on course taken)

Parent's Right to Know – Non-Highly Qualified Teachers

- Each year in the fall, all parents are notified if their child is receiving educational services from an individual that is not considered highly qualified by DESE
  - This may be educators with "pending" licenses
  - Educators that are teaching in areas outside their field -- i.e. an elementary teacher who is licensed (PreK-2) that is teaching a Grade 3; DESE allows ALL educators to teach 20% out of their field




